## OLD GLORY BUSINESS FLAG PROGRAM CONTRACT

The undersigned understands and agrees:

1. That an American Flag(s) will be placed on my building on the designated "Flag Days" listed below and will be put up around sunrise and taken down around sunset by Post 39 members on the days listed below.
2. The American Flag(s) under this program will not be stored at my business and that there is absolutely no work involved by me or my employees.
3. I, along with a member of Post 39, will decide where the permanent flag bracket(s) will be mounted on my building.
4. A member of Post 39 will securely install the bracket(s) at no charge. If I decide in the future that I do not wish to continue with this flag program, I can request that the bracket(s) be removed. Otherwise, they will remain on my building and I will not owe Post 39 for the bracket(s).
5. Proper flag etiquette dictates that the American Flag(s) will not be placed on my business in inclement weather.
6. Initial payment is due upon signing of this contract.
7. There is no price adjustment if this program is initiated mid-year.
8. This is an automatic annual renewal with payment due in advance prior to the end of the current year, it is considered a tax deductible donation to the American Legion Post 39, and as such there are no refunds if this program is cancelled mid-year. The Post has IRS Tax ID # 26-3616744.

It is also understood that I am not responsible if the American Flag(s) placed on my building is damaged or stolen. Replacement flag(s) will be supplied on the next scheduled day for flag placement. If the flag(s) is stolen, a police report must be filed. If this 2<sup>nd</sup> flag(s) is stolen, I and a representative from Post 39 will jointly decide if a different placement location for the bracket(s) is better suited for theft prevention. After the 3<sup>rd</sup> theft, Post 39 will remove me from the flag program unless I pay Post 39 for the replacement flag(s). Post 39 will replace any worn out or damaged flag under this contract at no charge.

The current scheduled days that the American Flag will be placed on my building are:

Veterans Day	Pearl Harbor Day (Dec 7)

Additional days may be added to this list as needed by national or state decree with no increase in the annual charge.
